
## Diving Queensland ANNUAL REPORT 2020

Diving Queensland would like to thank the Queensland Government, once again for their continued support & funding. Without their continued funding Diving Queensland could not do the good work they do.

## President's Report

2020 was a year of much uncertainty and change in every aspect of life and diving in Queensland was no exception. It was a year that brought many long months with no diving but also a year that brought unity in the sport with renewed optimism and a future where we work together as one team. My first and foremost thanks goes to our clubs and to Diving Australia for supporting our vision and uniting with us to create a future for diving in Queensland that is inclusive, progressive, passionate and supportive.

We were proud to launch the first Indigenous Diving Program in Australia in partnership with Hymba Yumba school in 2020. The program provided 15-20 students with 2 diving training sessions a term in terms 3 and 4. Thank you to Vyninka Arlow who provided significant support in getting this program off the ground. We look forward to continuing this partnership in 2021.

The Diving Queensland holiday program and Adult diving programs were a tremendous success in 2020 with the programs both reaching capacity. In 2021, we hope to grow both programs in partnership with our clubs.

In 2020, we also saw the partnership with Deaf Sport Queensland reinvigorated for a successful 6 week program. There was remarkable improvement in skill and confidence after the 6<sup>th</sup> session and we are keen to see the 2021 program deliver more opportunities to learn to dive.

2020 was also the year of facilities upgrades with Sleeman, Kawana and Centenary pools having both minor and major upgrades to dive pools and dive boards. This was a great outcome for clubs and divers.

Congratulations and many thanks to our Board members who have continued to provide guidance and support. The Board, the subcommittees and the dedicated team of volunteers are the lifeblood of diving in Queensland. Without the significate contribution of all of these people, we would be unable to deliver the competitions and programs that we had in 2020.

Thanks also to our Patron, Mr Greg Vickery OA, who continued to support us with his kind words, and his presence at our competitions throughout the year. We look forward to another year with Greg's patronage.

#### Coaching

Seven QLD coaches attended a Level 1 Coach workshop in September. All have now been accredited with Diving Australia as Level 1 coaches. We look forward to watching the progression of these coaches. Congratulations.

Thanks go to Tandi Hinchliffe, Jodie Gillam and Vyninka Arlow for her continued support and assistance with coaching accreditations in Queensland.

#### Competitions

We congratulate the competitions committee on an outstanding year of competitions in an incredibly difficult and ever changing COVID environment. Thanks to Stuart Graymore (Coordinator), Damian Smith, Toni Toohey and Heidi Graymore for ensuring the smooth and effective running of these events.

#### Communication

We have focused on improved communication in 2020 through social media, our database, our newsletters and emails to clubs and members directly. Our social media following and engagement has significantly increased. We will continue to focus on improving in communications in 2021.

#### Membership

Memberships dramatically increased in 2020 and we thank all clubs for sending recreational and holiday diver details to provide a more accurate record of diving in Queensland. With a clear base, we can now work to increase participation at all levels.

#### Officiating

A successful one-day judge's workshop was held in October. Heidi Graymore and Stuart Graymore presented the judges workshop and updated participants on current rule changes. Judges are assessed at all competitions which includes feedback and mentoring. It is compulsory for judges to attend one workshop a year to maintain accreditation. This includes judges at club competitions who must be accredited Level 1 judges, having attended both a workshop and completed the judge's exam with a pass of 80% or higher.

Thank you to all our judges and recording secretariat officials for your continued attendance at State, National and International events, representing QLD and Australia.

## Message from the State Administrator

It is with great pleasure that I present the 2020 Annual Report. Being involved with the Diving Queensland community for the past 19 years, I was delighted when I was offered the part-time position of State Administrator.



Whilst on certification, please be reminded that when judging at any level of competition each judge must have successfully completed the state judging workshop and have at least a level 1 status. This includes club & school events.

Last year's judging workshop was a great success, and we had many current and new judges attending. However, it is unfortunate that more qualified judges have not been active in pursuing the chance to shadow at Diving Queensland events to improve and progress their judging skills. It would be a great help to the Technical Committee and the Competitions Committee if more judges could make themselves available for our Diving Queensland events to help out with the competitions.

An important note to level three and above judges, it is important that you attend and judge at national events relevant to your level to improve your skills by judging a more diverse range of dives and secondly to be evaluated by other experienced judges to receive valuable feedback from them and third to increase your chances of elevating your judging level.

Diving Australia's National Technical Diving Committee (NTDC) have implemented a new officiating judging system and are continuing to update the relevant new policies. These policies have been ratified, and all current Diving Queensland judges should be aware of the changes and new requirements. Diving Queensland will devise and implement the required state workshop and include relevant information to you about the new officiating system.

I will look forward to working with you all again once the current environmental challenge that faces us allows us to be together again.

#### Technical Workshop

The Technical Committee held the Officials Workshop on 18<sup>th</sup> October 2020. Eight participants took part, including four new judges. All passed their exam and are now are Level 1 judges. The four remaining also passed and are looking at gaining more experience at both state and national level.

We had the pleasure of Eric Brooker from NSW presenting the finer points of judging synchro, and Simon Latimer from NZ presenting on psychology of judging diving.

# Recreational Diving

2020 saw a down turn in participation numbers because of the COVID-19 pandemic. We did, however, manage to hold a holiday program in September 2020.

Most sessions were oversubscribed which enabled us to offer additional sessions to keep up with demand. We have many participants that attend multiple sessions during holidays. We will continue to offer this program at a heavily subsidised cost to participants in order to expose our sport to as many people as possible. During all Diving Queensland holiday sessions, club flyers are handed out to parents. So far, the conversion rate to club level has been minimal with only one or two divers signing up to a club.

We have continued on with our GOLD & Adult diving lessons. Each week we offer a 90 minute lesson and it is wonderful seeing how many older people dare to be different!

Thanks to all the coaches that have assisted throughout 2020 with all these programs. We receive positive feedback about the running of our events.

#### **NOTES TO THE FINANCIAL STATEMENTS** FOR THE YEAR ENDED 31 DECEMBER 2020

#### NOTE 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

This financial report is a special purpose financial report prepared to satisfy the financial reporting requirements of the Associations Incorporation Act Queensland 1981.
